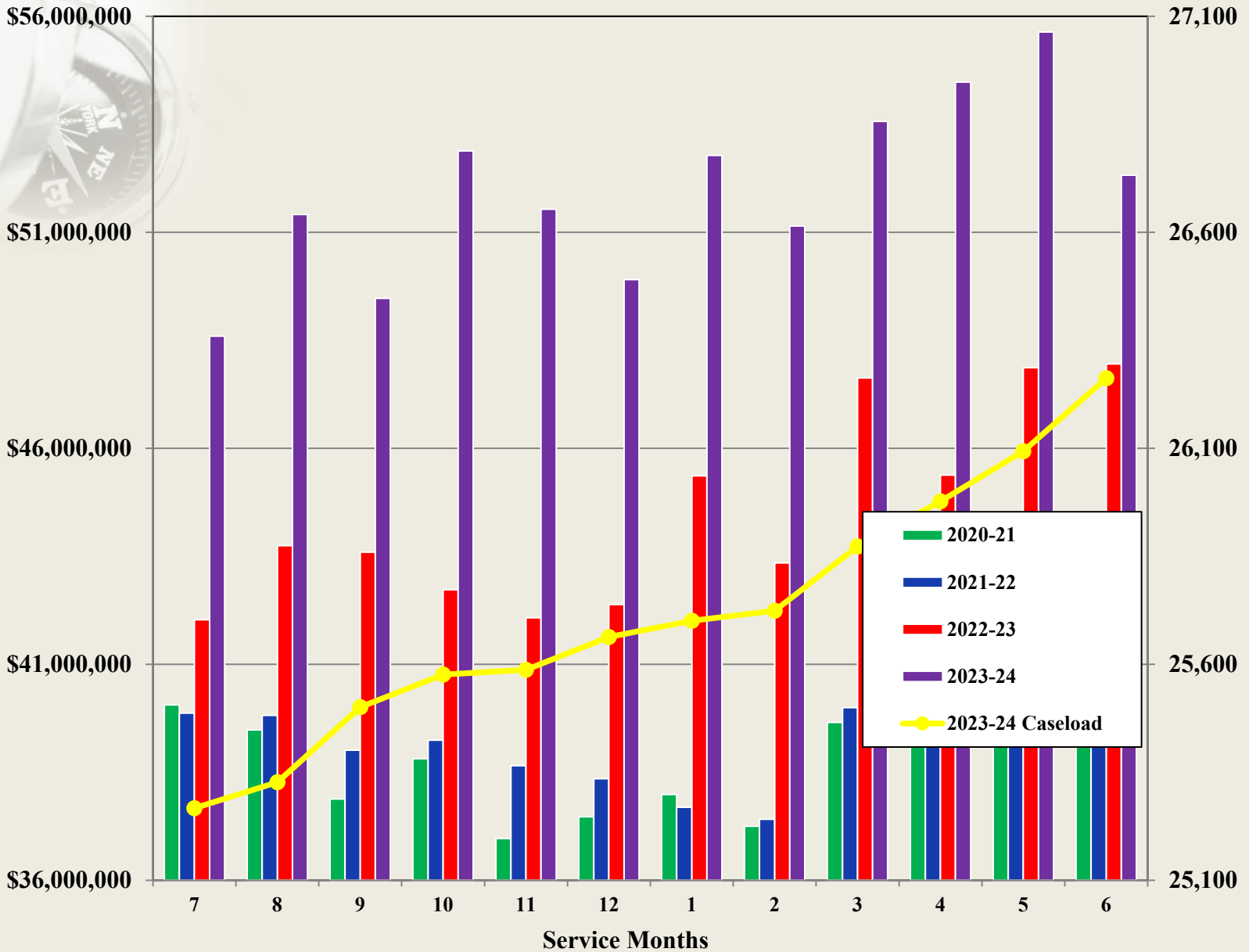
# Major Provisions in this Year's Trailer Bill Language

1. Elimination of the Family Cost Participation and Annual Family Program Fee programs
2. Adjustments to the assessment processes for children being considered for or enrolled in the Provisional Eligibility program
3. Ongoing allowance for remote planning team meetings for development of an Individual Program Plan (IPP) or Individualized Family Service Plan (IFSP) upon individual or family requests
4. A requirement that individuals with IPPs must be seen in-person by their service coordinator every twelve months and those with IFSPs must be seen in-person by their service coordinator every six months
5. Allowance for statistical sampling for service provider audits
6. Statutory requirements related to the Master Plan for Developmental Services, including its focus on accessibility, quality, and equity
7. Additional clarity about social recreation and camp services, including requirements for regional center staff training and the establishment of points-of-contact for these services
