DDS Provider Directory

- The Provider Directory is an online portal that will be used to input, store, and view information about all service providers in the state.
- The goals for the Provider Directory are:
 - Have visibility into California's network of developmental services providers
 - Establish consistency and standards for provider vendorization
 - Make it easier for individuals and families to find service options, leading to greater empowerment when selecting their services and supports

• Prior steps:

- <u>Step 1</u>-Vendors were to complete the data collection survey (due date 10/4/2024). Vendors that completed this step are eligible for a lump sum incentive payment.
- <u>Step 2</u>- Vendors were to verify information in the portal (due date 11/29/2024). Vendors that completed this step are eligible to receive the Quality Incentive Payment rate component.



DDS Provider Directory

- Based on information collected and verified, DDS has developed 5 provider groups:
 - Completed All Steps
 - Missing/Incorrect Data in the Directory
 - Submitted Survey and not in the Directory
 - Did Not complete Any Steps
 - New Vendor Numbers: No Available Vendor List

Rate Reform

- Rates for services that are a part of rate reform can be found by regional center at: https://www.dds.ca.gov/rc/vendor-provider/rate-reform/rate-models/
- Service type specific DDS Directives (https://www.dds.ca.gov/rc/vendor-provider/rate-reform/directives-updates/):
 - Service descriptions and implementation requirements
 - Staffing qualifications
 - Staff training requirements
 - Subcode combinations
 - Billing units
 - Staffing ratios



Rate Reform- Next Steps

- RCOC and the service provider shall affirm which updated service description and staffing requirements most closely match the services actually being delivered.
- RCOC shall verify the rate for each service and subcode combination in the rate workbook (provided by DDS).
- Beginning January 1, 2025, reimbursement for services will be claimed using the provider's current service code with an updated rate (provided by DDS).
- By March 31, 2025, the <u>Rate Reform Service Acknowledgement</u> <u>Form</u> shall be completed by RCOC and the service provider to acknowledge the service description, requirements that will need to be met, subcode combination(s), and rate(s) established by the rate model.

Quality Incentive Payment (QIP) Eligibility

Providers who completed the data collection survey (step1), for the Provider Directory, by October 4th may be eligible for the 10% QIP. www.dds.ca.gov/initiatives/provider-directory/

Hold Harmless

Providers with existing rates that are above 90 percent of the rate model for the service description to which they will align will maintain their existing rates (held harmless) until June 30, 2026.
